Reference to the Ministerial Order N° 002/17/10/TC of 27/10/2017 determining the fees for registration of Pharmaceutical products, medical devices and other related services, the Ministry of Health would like to bring to the attention of all its esteemed clients that, all services rendered by the pharmaceutical services in the Ministry of Health will be issued upon receipt of payment.

The Ministry of Health would like to take this opportunity to inform its clients that, it will start charging the prescribed fees in the Ministerial Order from 7th May 2018.

All clients will be required to seek relevant services through the Rwanda Revenue Authority system and pay on the RRA Accounts in Rwandan Francs or in US Dollars.

Thereafter, a Payment receipt be attached to the request or be uploaded in the system with the application as may be necessary.
